
Address from

Addition to Referve (ATR)

Eel River Bar has been in the process of working towards an Addition to Reserve. This means that the Band has historically purchased and is currently in negotiations to purchase parcels of land. These additional lands are needed for the growing population to ensure sufficient housing, economic development and future needs of the community.

In order for a Reserve Creation Proposal to move forward, the following criteria must be satisfied:



There are no significant environmental



Best efforts have been made to address any concerns of municipal and provincial or territorial governments



The proposal is cost-effective and any necessary funding has been identified within operational budgets



Third party issues, such as leases and licenses have been identified and addressed



Public access concerns have been addressed

Five stages to the Addition to Reserve Process

Step 01

Initiation

Eel River Bar submits a Band Council Resolution and Reserve Creation Proposal to the Indigenous and Northern Affairs Canada (INAC) regional Step 02

Assessment and Review

INAC reviews the proposal and advises Eel River Bar in writing of the results, issuing a letter of support to First Nations with successful proposals Step 03

Proposal Completion

INAC and Eel River Bar work together to create and execute a work plan to complete the proposal Step () H

Approval

The Minister of Indigenous and Northern Affairs approves proposals by Ministerial Order or recommends approval by the Governor in Council for Order in Council proposals

Step **05**

Designation

Eel River Bar consults the community if the land requires special designation (ie. for Economic Development Purposes)

Future Entrepreneur Loan

The Future Entrepreneur Loan program provide the opportunity for youth aged 19 and under from the Chaleur region who wish to acquire work experience by creating their own micro-enterprise. The CBDC Chaleur proposes to support the entrepreneurial development of young people by offering them the opportunity to borrow up to \$1,500 under favorable conditions in order to foster their entrepreneurial spirit.

In short, this program suitable for emerging young entrepreneurs includes the following elements:

- Loan amount up to \$1,500
- 0% interest
- 19 years old and under
- Flexible reimbursement schedule
- Grant up to 30% of the loan value



To be eligible for the 30% reimbursement of the loan value, the future entrepreneur must:

- Reimburse his loan 12 months after the beginning of the start-up;
- Produce a final report explaining the operation of the business.

Why a Future Entrepreneur Loan in the Chaleur region?

- To encourage and support the creation and development of new businesses;
- To create awareness to youth entrepreneurship for business start-up;
- To promote the programs and services available for SMEs;
- To encourage networking between the future entrepreneur and local business owners.
